CHALLENGES BEHIND MANAGING YOUR OWN COMPLIANCE AND SECURITY

Traditional fax is generally accepted as secure, related to its realtime occurrence and use of the public switched telephone network (PSTN). Even so, there are security and compliance concerns for this method, mostly related physically to the printing involved:

1. KEEPING PRINTED DOCUMENTS SECURE

The paper used to send an outbound fax and receive an inbound fax must be properly controlled and destroyed.

2. ENSURING CORRECT FAX ROUTING Inbound faxes must be routed to the correct person.

3. ACCESS CONTROL

Fax machine access must be restricted to prevent an unauthorized person from picking up a fax.

Electronic fax solutions have different but equally burdensome compliance issues. Organizations managing their own fax servers are now dealing with digital forms of their documents and must ensure their server is updated with the latest software patches, running antivirus software, protected via firewalls from intrusion, etc.
